1. Introduction

The International Charter School of Atlanta (ICSAtlanta) invites qualified design-build teams to submit proposals to provide comprehensive design and construction services for capital improvements at its Upper Campus located at 1675 Hembree Rd, Alpharetta, GA 30009.

The objective is to complete necessary renovations, upgrades, and amenities to enhance the learning environment, address facility needs, and align with the school's mission of providing an international, multilingual education while instilling cultural awareness, respect, and tolerance for others.

Scope of Work (general):

- Enhance / modernize canopy at entrance (see attached inspirational images), replace perimeter sidewalks, upgrade landscaping and grading at entrance creating a new greenspace.
- New canopy at student drop-off, with connection to entrance canopy, replace sidewalks in same area with extension for added student capacity
- Parking lot scope is mill and repave existing parking lot and entrance drive

3. Project Goals

- Provide safe, modern, flexible learning spaces.
- Deliver cost-effective design and construction solutions.
- Minimize disruption to ongoing school operations.
- Complete the project on schedule and within budget.
- Foster collaboration between school leadership, staff, and the design-build team.

5. Submission Requirements

Proposals must include, at a minimum:

1. Cover Letter – Brief introduction and expression of interest.
2. Team Qualifications – Resumes of key personnel and relevant experience.
3. Firm Experience – Summary of similar K-12 or charter school design-build projects.
4. Approach & Methodology – Description of design approach, project management, cost control, and communication plan.
5. Preliminary Schedule – Proposed timeline with key milestones.
6. Fee Proposal – Breakdown of design and construction services – design fees will be converted into a fixed cost as the initial agreement. Construction costs shall be established at the time of Guaranteed Maximum Price at the Construction Documents milestone.
7. References – Minimum of three (3) relevant client references with contact information.

6. Evaluation Criteria

Proposals will be evaluated based on:

- Qualifications and experience of firm and key personnel.
- Relevant project experience.
- Approach and understanding of project goals.
- Proposed schedule and ability to meet deadlines.
- Fee structure and value offered.
- References and past performance.

7. Pre-Proposal Meeting

A mandatory pre-proposal meeting and site walkthrough will be held at the Upper Campus on January 15, 2026. Attendance is required to submit a valid proposal.


