PURPOSE AND DESCRIPTION

The International Charter School of Atlanta (ICSAtlanta) is seeking quotes from qualified, licensed businesses to construct a playground at our school's Upper Campus, located at 1675 Hembree Road, Alpharetta, Ga 30009. This playground will be constructed on a concrete slab that is currently used as a basketball court/play area.

QUOTE REQUIREMENTS

- Bidders must be aware of any requirements for safe playground installment practices in schools and propose only materials that adhere to such standards. All materials must meet local and state code requirements for commercial structures.
- The contractor is required for securing and paying for all permits as required to complete the Work.
- The building was constructed in 1986; however, if during the construction of the Work the Contractor encounters any material suspected to be hazardous (such as asbestos), they are to immediately suspend work and notify ICSAtlanta.
- For the purposes of the Contractor's bid, provide both (1) an itemized price for each piece of play equipment, each bench, each shade structure, the entire area of ground cover (including turf, padding, and any other material needed for ground cover installation), and installation and (2) a single lump-sum price for the completion of the Work. ****Please note we are a tax-free institution.**
- Provide, as part of your bid, product specifications for materials and equipment used for the new playground (including, but not limited to ground cover, padding under ground cover, play equipment, benches, and shade structures).
- Bidder must ensure that all play equipment and padded turf areas are International Play Equipment Manufacturers Association (IPEMA) certified.
- Bidder must ensure adequate and proper drainage for playground area for rainwater runoff.
- Bidder must provide a sample of the manufacturer's warranty to be provided upon completion of the Work for all materials and equipment (including, but not limited to

ground cover, padding under ground cover, play equipment, benches, and shade structures).

- Bidder must provide a schematic of the playground (including, but not limited to placement and dimensions of all pieces of play equipment, benches, and shade structures).
- Bidder must provide a schematic of the playground ground covering from that includes dimensions, parameters, color scheme (with actual dimensions/shapes of each color) and placement of play equipment, benches, and shade structures within this schematic.
- Bidder must provide two references where your company provided a similar type of installation to the one being proposed in your bid.
- The base bid should assume a single mobilization. Bidder must provide a schedule or the number of days required to complete the work.
- Bidder must conduct a site visit prior to submitting a bid. Site visits may be coordinated with LiDina Singh at lidina.singh@icsatlanta.org.
- Bidder must provide a sample of your company's standard Certificate of Insurance detailing insurance coverages and limits.
- Qualified bidders must be licensed by the State of Georgia and provide a certificate of insurance for no less than \$1,000,000 upon contract award.
- Bidder must include the following playground equipment/materials or comparable equipment (equipment colors in navy, royal blue, black, and/or gray):
 - [Octanite](#) (or comparable equipment)
 - [Twin Ring Carousel](#) (or comparable equipment)
 - [BloqX 2](#) (or comparable equipment)
 - [Track Ride Tower w/ ADA Platform](#) (or comparable equipment)
 - [CometTrail 60 benches](#) (or comparable equipment)—total of 2
 - [Crescent 60 benches](#) (or comparable equipment)—total of 5
 - Ground cover (turf and padding (IPEMA compliant) to cover existing concrete slab (approximately 85' by 70') in green (approximately 55'x70) and royal blue (approximately 30' by 70') with circles of royal blue around bench areas.
 - Shade structure/structures to cover play equipment area (approximately 50' by 60')
